



## DAYCARE REGULATIONS

### DEFINED:

**Daycare Centers (Nursery School) are allowed by Special Use Permit in the “R-1”, “R-2”, “R-3”, “R-4”, “R-5”, “MH”, “M-2”, “B-1”, “B-2”, “B-3” & “PR” Districts.**

**14-1-11 (B) “DAYCARE CENTERS (Nursery School).** Any childcare facility which regularly provides daycare for less than twenty-four (24) hours per day for more than eight (8) children in a family home or more than three (3) children in a facility other than a family home.

**Daycare Homes are a permitted use in the “C”, “R-1”, “R-2”, “R-3”, “R-4”, “R-5”, “MH” AND “M-2” Districts if providing daycare for no more than eight (8) children.**

**14-1-11 (B) “DAYCARE HOMES”.** Family homes that receive more than **three (3)** and up to a maximum of **twelve (12) children** for less than **twenty-four (24) hours** per day. The maximum of **twelve (12) children** includes the family’s natural, foster or adopted children and all other persons under the age of **twelve (12) years**. The term does not include facility that receives only children from a single household.

### REGULATIONS:

**14-4-22 Daycare Homes** – In any district where daycare homes are permitted, the following requirements shall be met:

- (A) Daycare homes shall have received a license from the State of Illinois under the Child Care Act of 1969 (**225 ILCS Sec. 10/0**) from the Department of Children and Family Services.
- (B) Exterior storage and use of playground equipment in good repair shall be allowed.
- (C) Fencing or appropriate enclosure of outdoor play area shall be required when children are permitted outdoors.
